BSACI membership is open to all engaged in clinical practice, research, teaching or studies relevant to allergy and/or clinical immunology.

BSACI is the national, professional and academic society representing the specialty of allergy at all levels. Its main objective is to improve allergy care – through education, training and research. It achieves this by:

- Informing opinion leaders by campaigning to improve allergy services.
- Encouraging research into allergic diseases and disorders of the immune system.
- Providing allergy education for both primary and secondary care clinicians, scientists and allied health professionals.
- Promoting allergy education for undergraduate medical students.
- Representing the specialty at the Royal College of Physicians (RCP), Royal College of Paediatric and Child Health (RCPCH), Joint Committee of Immunology and Allergy (JCIA) and within the National Allergy Strategy Group (NASG).
- Working with other organisations to educate and raise awareness of allergy nationally.
- Providing educational opportunities and to build closer links with other disciplines including ENT surgeons, respiratory physicians, dermatologists, gastroenterologists and dietitians where allergy may be a subspecialty interest.
- Maintaining international collaboration, for example with the World Allergy Organisation (WAO), the European Academy of Allergy and Clinical Immunology (EAACI) and the American Academy of Asthma, Allergy and Immunology (AAAAI).

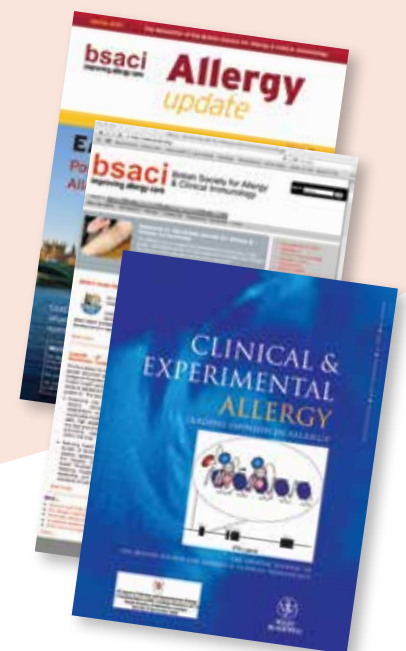
Benefits

Junior members are also given preference when applying for BSACI Travel Fellowships.

- **Student member**
