Provide networking opportunities and collaboration for adult allergy through the clinical support groups by reviewing existing networks, their activity and function (Adult Allergy Committee)	Assess whether the network system is working post pandemic – is it compliant with the specialist standards (audit?)? (IQAS) Add a list of adult networks to the website. Link with Paediatric Allergy Committee, Primary Care Committee and Clinical Immunology Committee (& UKPIN). Involve other BSACI groups in these networks. Incorporate the education strategy. Note new Integrated Care Systems (ICS) – where members will need to liaise with their local ICSs.
Undertake an options appraisal for expansion of Allergy services to areas of unmet need (Adult Allergy Committee)	Look at devolved nations in the National Allergy Strategy Group (NASG); get more involvement from other nations talking about their local challenges and how BSACI can support. Think about the best model for hubs to support spokes across UK, particularly primary care.
Review access to care within the UK by identifying the numbers of specialists and clinics to identify areas of the highest need. (Adult Allergy Committee) (To inform policy work)	Liaise with Michael Perkin to see if we can (partially) replicate the paediatric survey. Feed into clinic list on the BSACI website.

### Public/patient engagement to improve health

Strategically how involved should the BSACI be involved in patient facing activities. BSACI aims are professional facing but we are increasingly undertaking patient facing activities which are traditionally the patient charities focus. All present at the strategy meeting felt that BSACI should be professional facing and should work with charities on patient facing work but not directly develop patient facing information ourselves. Charities feel that they should be generating patient information leaflets. This was discussed further at council in May 2022 and agreed to:

- 1. Support charities to generate patient facing information & translations
- 2. Restrict BSACI lead activities to development of specific patient documents where they are integral to the workings of an allergy service, eg allergy action plans
- 3. Complete activities that are currently ongoing ensuring that charities are involved
