PRESIDENT'S WELCOME

Professor Roberts welcomed members to this year's online AGM. Members were advised that the chat function was available for any members to use for their questions. Dr Mohamed Shamji submitted a recording of the editor's report, and Dr Robert Boyle was in attendance and available to answer any queries.

1. APPROVAL OF 2021 AGM MINUTES

A copy of the 2021 AGM minutes and other documentation were circulated to the membership prior to this meeting. 48 Members voted on the motions via Survey Monkey ahead of this AGM, so a record of those results would be included in the minutes.

2. PRESIDENT'S REPORT

(Professor Graham Roberts)

The President started his report by highlighting some of the work carried out during his first year and the challenges addressed over the course of his tenure. Members were reminded that elections for the President Elect were due to take place in 2023.

One of the year's highlights was the joint BSACI and World Allergy Organisation (WAO) conference which took place in April 2022. The President thanked Dr George Gkimpas, the Past BSACI Scientific Programme Lead, for whom this meeting would be his last; and the Joint Deputy Scientific Programme Leads, Dr Nandinee Patel & Dr Natasha Gunawardana, for all of their hard work in organising the annual meeting. He also thanked Dr Tammy Rothenberg (Abstract Lead); Louise Colonnese (BSACI Marketing & Communications Officer); members of the Programme Planning & Organising Committee; the BSACI Office staff; and the Medivents team (the conference's professional organisers).

Additional thanks were given to everyone who has worked hard on the BSACI committees and contributed to the organisation's work. It was noted that Dr Sophie Farooque, who worked on the Equality Diversity and Inclusivity Working Group, and Dr Rubaiyat Haque, who led the very successful BSACI webinar programme, have now finished their terms on Council. Dr Dinusha Chandratilleke has now been appointed as the new lead for webinar planning.

Council has agreed to the addition of two further working groups. These are the BSACI Transition Group which is co-chaired by both Dr Claudia Gore (Paediatric) and Dr George Gkimpas (Adult); and the BSACI Adult Gastroenterology Group which is chaired by Dr Isabel Skypala.

Finally, thanks were given to the trustees, Dr Susan Leech (Treasurer), Dr Deb Marriage (Secretary), Professor Adam Fox (Past President) and Fiona Rayner (BSACI Chief Executive Officer.)

National Allergy Strategy Group (NASG)

The president announced that this year Dr Pam Ewan stepped down as Chair of the NASG and welcomed Professor Adam Fox as her replacement. Dr Ewan will continue working on the NASG as the new President and Professor Roberts said that the BSACI was grateful for her dedication to the BSACI. He also thanked Professor Stephen Holgate who has stepped down as President and Co-founder of NASG. Professor Holgate will remain an expert advisor to the NASG.

The NASG, which is an alliance of the BSACI, Allergy UK and Anaphylaxis UK, is a critical lobbying group. The group has been successful, particularly regarding the NASG and All-Party Parliamentary Group (APPG) report, entitled "Meeting the Challenges of the National Allergy Crisis", which was delivered to the Department of Health and Social Care. The next step for the NSAG is to form an expert group which will provide leadership and work continuously to keep allergy at the top of the government's agenda.

Online Global Symposium

Professor Roberts advised members that the BSACI will be hosting its first online Global Symposium on Friday 10 February 2023, in collaboration with the European Academy of Allergy and Clinical Immunology (EAACI), the American Academy of Allergy, Asthma & Immunology (AAAAI) and WAO.

BSACI Annual Conference

The date of the next BSACI Annual Conference is 5 - 7 October 2023.

New BSACI Office Appointments

The President announced the following New BSACI Office Appointments:

- Vivine Smith Operations Manager to free up Fiona's time so she can focus on strategy and sustainable funding

and he thanked everyone at the BSACI Office for their hard work.

Highlights from the Past Twelve Months

The President discussed the following highlights:

- Two new guidelines have been published:
 - Diagnosis and Management of Pollen Food Syndrome led by Dr Isabel Skypala
 - Penicillin Allergy De-labelling led by Dr Louise Savic.
- Dr Isabel Skypala has been appointed as the Standards of Care Committee (SOCC)
 co-chair to support Dr David Luyt. SOCC is reviewing the BSACI guidelines
 standards of practice and would appreciate suggestions from members for new
 guidelines.
- Dr Natasha Gunawardana has driven a new three-year training programme for adult trainees which covers the Allergy and Immunology Curriculum.
- The BSACI and the Royal College of Physicians Training Board held a joint Allergy and Immunology training curricula Webinar in May. Members were advised that a recording was available on the BSACI website.
- The monthly online programme of webinars and grand rounds has been popular among the membership and the President thanked Dr Liz Powell and Rubaiyat Haque for having facilitated these.
- Patient Information Leaflets are being finalised and will be available on the BSACI website soon.
- The Adult Allergy Emergency Plan is being worked on, which was originally led by Kathryn Powrie.

- Three of the current guideline working groups assembled are:
 - NSAIDs, led by Dr Rita Mirakian
 - Management of Palforzia, led by Dr Deepan Vyas
 - Urticaria, led by Dr Chris Rutkowski.
- The UK Fatal Anaphylaxis Register is being led by Dr Vibha Sharma
- A successful meeting at Dumfries house was led by Professor Sir Stephen Holgate on "Understanding the environmental causes of allergic disease in order to identify effective interventions". The President said that a review was being planned and hoped to be shared at the BSACI online Global Symposium on 13 February 2023.

The Special Resolution

Professor Roberts explained the rationale of ensuring the Articles of Association reflect how the BSACI works today. Therefore, an amendment to the articles is proposed so that they are explicit when there is a need to hold a virtual AGM.

The UK currently has two anaphylaxis registers:

- 1. UK Fatal Anaphylaxis Registry (UKFAR) based at Central Manchester Hospitals NHS Trust (Dr Vibha Sharma)
- 2. National Anaphylaxis Registry based in Imperial College London (Dr Paul Turner).

The Anaphylaxis Steering Committee's remit is wide-ranging which includes not only supporting these two centres to mitigate risk but also securing future funding to enable us to utilise the registries' data.



Honorary Membership Category

Currently, the BSACI has four honorary members who do not pay membership fees but have access to member benefits. The proposed change aims to reshape the Honorary Membership category in order to reflect the BSACI today.

A new Fellows Award category will be introduced and available for BSACI members with at least 20 years of continuous membership. Henceforth, Honorary Memberships will be granted to non-members who have made a significant contribution to the field of Allergy and Clinical Immunology.

Membership Application Process

The requirement for new applicants to have two current (in good standing) BSACI Members propose and second applications might be a barrier to joining, particularly for those who do not know any BSACI members. The new application process will remove the need for referees, although applicants should show allergy experience. As per usual, new members will be approved by Council.

Junior Membership Category

Presently, the definition/criteria for Junior membership is: 'To qualify members must be under 35 years old **or** any non-clinician within five years of their last higher degree (e.g., PhD, MSc) **or** any clinical trainee in allergy **or** clinical immunology or a related clinical speciality'. This amendment aims to remove any confusion for applicants or current members surrounding the criteria regarding age.

Rolling Membership Subscriptions

At present, the BSACI runs a fixed membership year running from 1st August to 31st July. Members joining partway through the membership year are charged a pro-rata fee for the remaining months' membership. To ensure all members receive exactly 12 months of membership from the point of application, it is proposed we move from a fixed membership year to rolling membership subscriptions where the 12-month membership year starts once an application is approved.

Monthly Membership Subscription

The BSACI currently offers only one-off payment methods for membership either by annual direct debit or by card payment. In order to offer a more affordable payment option for members that may find paying the full subscription fee in one go a challenge, we propose allowing members to spread the subscription cost monthly. This would still be a 12-month membership, but with the option of splitting the payments over 12 months.

4. TREASURER'S REPORT

(Dr Susan Leech)

The BSACI's financial year runs from August to July.

Year Ending July 2022 Income and Expenditure

Dr Leech said the BSACI's income had come in above the forecasted budget.

At the 2021 AGM members were asked to authorise a transfer from our investments of £169,907. However, due to the Harrogate and Edinburgh meeting leading to a 180k surplus, it was not necessary to do so.

Expenditure

The number of staff has increased due to additional appointments.

The figure for membership and bursaries is lower than anticipated because there were no medical scholars last year. Funds allocated to the abstract awards were transferred to the annual meeting budget in 2021.

After the conference, we agreed to reimburse WAO for a number of WAO speakers' expenses which was £15,350.

Future Developments

Dr Leech said that we have an ambitious organisational strategy we wish to undertake over the next few years. A funding plan has been drafted which will help us sustain long-term stability in order to be able to deliver our objectives. At the 2021 AGM, we projected our expenditure would rise to £445,243 as a result of:

- Investment in the next generation of allergy specialists by funding a £15,000 medical scholarship programme.
- The appointment of an Operations and a Communications and Marketing Manager to support the delivery of a wide range of activities including across our digital communication channels.

Many organisations have suffered financially as a result of COVID. However, the BSACI's finances have remained robust and, thankfully, it was not necessary to make any staff redundancies.

The Treasurer responded to a question regarding £35k tax costs. She explained that the actual amount related to the annual meeting but noted that it varied from year to year depending on where the meeting was held and whether it was virtual or in person.

REPORT FROM CO-EDITOR OF CLINICAL & EXPERIMENTAL ALLERGY (CEA) (Dr Mohamed Shamji)

The work carried out by the CEA co-editors Dr Mohamed Shamji and Dr Robert Boyle is supported by the Wiley Blackwell and BSACI teams. The journal has seen its impact factor rise from 5.01 in 2021 to 5.401 in 2022. This increase has been a result of a close collaboration between the editors, associate editors and the global editorship.

The CEA currently publishes a wide spectrum of articles for its readers and includes new features such as Cochrane Corner, clinical questions, clinical practice guidelines, debates and correspondence.

Dr Shamji also highlighted some of the journal's achievements such as having open-access articles; the inclusion of harmonised graphic abstracts; and a reduced 'submission to acceptance' turnaround time for articles. The CEA has also enjoyed a well-received social media presence.

5. REPORT FROM THE WAO/BSACI CONFERENCE IN APRIL 2022 (Dr George Gkimpas)

Dr Gkimpas said that the WAO/BSACI 2022 conference was highly successful and thanked everyone who supported this global allergy-focused meeting. Out of the 857 delegates, a quarter came from countries outside the UK such as South Korea, Argentina, South Africa, New Zealand, Bulgaria and Hong Kong. Registrations also included attendees from a range of professional categories, as well as a high number of non-BSACI members.

Some of the conference highlights were Dr Thirumala Krishna's speech on Allergy Management in India; Professor Sir Stephen Holgate's presentation on Clean Air Day; and a unique year-in-review session in collaboration with EAACI, AAAAI and the Japanese Society of Allergology (JSA.) The new 'Allergy Education' session, introduced in 2021, was well received this year.

Finally, Dr Gkimpas thanked the programme planning committee for their input into the programme this year as well as the joint Deputy Leads, Dr Nandinee Patel and Dr Natasha Gunawardana, who have been appointed as the new Annual Meeting Committee's Joint Scientific Programme Leads.

Via the chat, it was asked whether Reckitt Benckiser had been a meeting sponsor. Fiona Rayner answered that it had and that its presence was in line with BSACI Industry Policy.
